RULES FORMAT (FROM ORA BINDER G&T SECTION)  
 Player Registered on Two Teams - Playing Agreement

1. A player may register on an "A" or "AA" TRF while registered on a lower level ("B" or "C") team either in the same or a different association.
2. A player may play in a Provincial Championship and the Regional Championships.
3. Priority is to the lower level team through the following Agreement between both coaches and player/parents. The general hierarchy is Championships before Tournaments; Tournaments before Games; Games before Practices, Practices before Meetings; and Meetings before Social Activities. If all concerned agree when the hierarchy is different in a given situation, the agreed to solution can be approved.
4. Any amendments to this Agreement must be initialled by all of the concerned parties and the Regional G&T Co-ordinator.
5. Disputes over team loyalties and interpretation of the Agreement must be brought to the G&T Co-ordinator for resolution.
